TERMS AND CONDITIONS

1. THE apartment shall be handed/allotted to those members who have made all the payments/dues as per payments schedule. The management is not obliged to allot apartment to those who do not pay their installments in time.
2. The payment of installment must be made **within 5 days** of given dates. The defaulter shall be liable to pay **5%** as penalty on due installment per month. The allotment of said apartment shall be treated as cancelled in case the due installment is not received within 60 days from the due date. The paid amount shall be refunded by the seller to the purchaser after deducting **20%** of the total paid amount, such refund only be made after completion of project once the said apartment is sold to some other party.
3. **RELIANCE BUILDERS** reserved the sale rights of Shop/Office/flat which members not paid installments on time; without any cancellation Notice.
4. The seller can cancel the membership of the person who violating the conditions set for the **"Park View Plaza"**.
5. The purchaser is allowed to sell the Shop/Office/Flat before taking possession; However a prior written permission is required from the seller; besides the purchaser shall also have to pay Rs. 30/- (per sq/ft) for flat and 130/- Sq. Ft. for shops and offices as transfer fee to the **RELIANCE BUILDERS**.
6. The purchaser is not allowed to utilize the common passage/stairs of the building. All common passages/stairs in the building shall be used by the occupants/purchaser of the said building commonly.
7. The occupant/purchaser has to pay sum of Rs. 8,400/- for the maintenance services i.e. Security, water etc per annum.
8. A discount of **5%** applies if the applicant wishes to pay the full amount at the time of booking.
9. The purchaser shall install Sui Gas and electricity connection at his own cost.
